

THE CORPORATION OF THE TOWN OF ORANGEVILLE

BY-LAW NUMBER 57-2002

BEING A BY-LAW TO AMEND BY-LAW NO. 125-86, WHICH IS A BY-LAW TO REGULATE TRAFFIC AND PARKING IN THE CORPORATION OF THE TOWN OF ORANGEVILLE.

WHEREAS the Council of the Corporation of the Town of Orangeville deems it expedient to amend By-law No. 125-86, as amended.

BE IT THEREFORE ENACTED by the municipal council of the Corporation of the Town of Orangeville as follows:

1. THAT Section 4 of By-law No. 125-86 – Free two-hour parking and permit parking be deleted and replaced with following:

Section 4

- 4.1 (a) The provisions of this Section 4.1 shall apply to the Pesterin and Zina Street Parking lots which shall be suitably signed and/or marked as permit parking lots only, for use by users of monthly parking permits, herein referred to as "Permits" These lots are more particularly described in Schedule L.
- 4.1(b) Parking Permit(s)

No person shall allow a vehicle to remain parked upon the parking lots described in this Section unless the owner or operator thereof has procured a parking permit permitting said parking from the Treasurer or Designate of the Corporation of the Town of Orangeville.

- 4.1(c) Parking Permit
 - (i) a vehicle owner may purchase a monthly parking permit from the Town of Orangeville Treasurer or Designate.
 - (ii) the monthly parking permit will be issued upon payment of a fee of Twenty Five Dollars (\$25.00) plus applicable taxes.
 - (iii) Parking permits may be purchased for an extended period up to one year.
- 4.1(d) Parking Permit Displayed on Windshield
 - (i) the parking permit referred to in this Section shall be displayed on the windshield of the vehicle while parked on off-street parking lots described in this Section.
 - (ii) the parking permit shall be displayed so that it is clearly visible from the outside of the vehicle.
- 4.2 Restricted Parking
- 4.2 (a) Where official signs in accordance with the regulations of the Highway Traffic Act have been erected and are on display, no person shall park a vehicle on a portion of the highway described in Columns 1 and 2 of Schedule J of this By-law, for a longer period than that is set out in Column 3 of the said Schedule J.

- 4.2 (b) No person shall park a vehicle in the off-street parking lots listed in Schedule K of this By-law for a longer period than is set out in Column 3 of the said Schedule K.
- 4.3 Controlled Parking
- 4.3 (a) No person shall park a vehicle in a controlled cali machine parking lot for a longer period than that for which payment has been made in the form of coins deposited in the control device, provided, however, that this shall not prevent the person of a subsequent vehicle from using the un-expired time remaining from the control device from its previous use without depositing funds within.
- 4.3 (b) Notwithstanding the provisions of Section 4.3 (a), no person shall park a vehicle in a controlled parking space which is controlled by a parking control device for a period longer than twelve hours in any twenty-four hour period.
- 4.3 (c) Where official signs in accordance with the regulations of the Highway Traffic Act have been erected and are on display, no person shall park a vehicle in a controlled parking lot as described in Column 2 of Schedule M of this By-law, for a longer period than that is set out in Column 4 of the said Schedule M.
- 4.3 (d) No person shall park a vehicle in a controlled parking lot without depositing funds as described in Column 2 of Schedule M of this Bylaw.
- 4.4 General Provisions
- 4.4 (a) Overnight Prohibited

No person shall park a vehicle in the parking lots described in this Section between the hours of 11:30 p.m. and 7:30 a.m. on any day from December 1st of one year to March 31st of the following year.

4.4 (b) Overnight Permitted

The provisions of Section 4.3 (a) shall not apply to authorized emergency vehicles and vehicles registered to the Corporation of the Town of Orangeville.

4.4 (c) Obstruction – Parked – Standing Vehicle Prohibited

No person shall park a vehicle, in such area described in this by-law, in such a place or position as to prevent the convenient removal of any other vehicle previously parked or standing.

- 4.4 (d) No person shall park a vehicle the length of which is in excess of 7 meters in length and 3.5 meters high in any area described in this by-law.
- 2. THAT Schedule I, (voluntary fine) of By-law No. 125-86 as amended by By-law 62-89 as amended by By-law No. 23-96 be deleted and replaced by Schedule I attached hereto for certain traffic and parking offences.
- **3.** THAT Schedule G of By-law No. 125-86 with respect to fees for metered parking spaces be deleted.
- 4. THAT By-law No. 62-89 and 23-96 be repealed.
