**BY-LAW NUMBER 83- 2006**

**BEING A BY-LAW TO AMEND BY-LAW 22-90 AS AMENDED** (Carmen DeGasperis, 288 Broadway 2 Dawson Road; OPZ 2/06).

**WHEREAS** on May 29, 2006, Council held a public meeting with respect to Official Plan and Zoning Amendment Application OPZ 2/06 to permit the conversion of the existing dwelling into a specialty restaurant/café for the retail sale of Italian ice cream, pastries, coffees, etc.;

**AND WHEREAS** on July 10, 2006, Council approved the application;

**BE IT THEREFORE ENACTED** by the Municipal Council of the Corporation of The Town of Orangeville as follows:

1. THAT Zoning Map C3 is hereby amended in accordance with Schedule "A" hereto;
2. THAT Section 24 of By-law 22-90, as amended, is hereby further amended by adding the following thereto:

"24.173 Notwithstanding the provisions of Section 8.1 hereof (Permitted Uses) a specialty restaurant/café to a maximum floor area of 117 square metres shall be permitted in the existing building as it substantially existed on July 10, 2006, on the lands comprising Lots 74 and 75, Registrar's Compiled Plan, and zoned R2 Zone, Special Provision 24.173.

Should the building cease to exist, this Special Provision will no longer apply to these lands."

BY-LAW READ THREE TIMES AND FINALLY PASSED IN OPEN COUNCIL THIS 10TH DAY OF JULY, 2006.

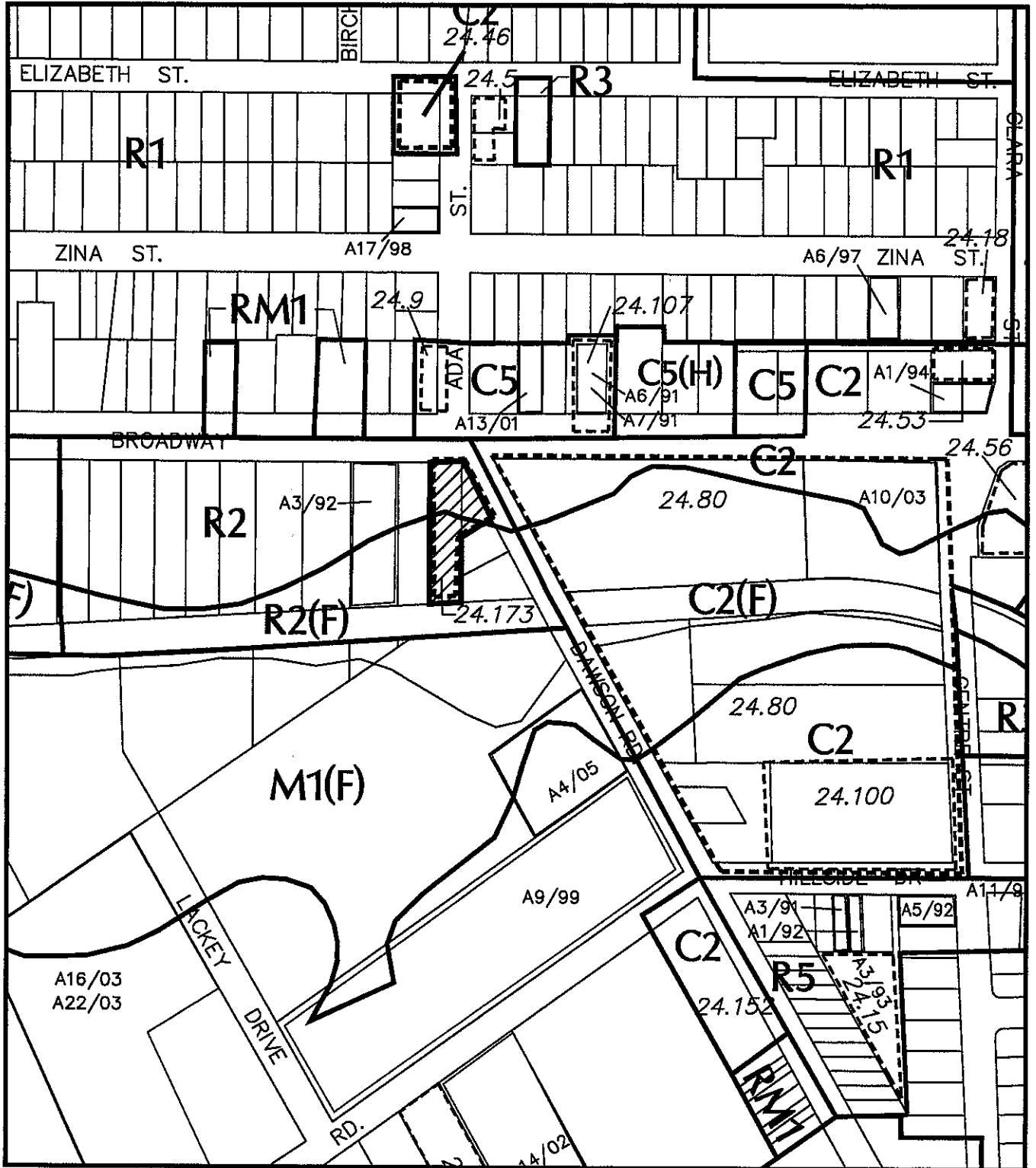

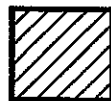
