LOCATION OF PROPERTY: Part of Lot 257, Registered Plan 100  
6 Highland Drive

PURPOSE OF APPLICATION: The applicants are requesting a minor variance to reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to 4.3 metres (14.11 feet) in order to permit the construction of an enclosed porch at the front of the dwelling.

**CONDITIONS:**

1. That the dimensions of the enclosed porch do not exceed 2.1 by 1.8 metres.
2. That the porch and stairs are located such that one parking space, a minimum of 2.7 by 5.5 metres, continues to be provided on the property in accordance with the requirements of Zoning By-law 22-90, as amended.
3. That a window be included at the north elevation of the enclosed porch.

**REASONS FOR DECISION:** The variances as approved are considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
