LOCATION OF PROPERTY: Lot 8 and Part of Lot 9, Block 4, Registered Plan 159
5 First Avenue

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to 4.4 metres (14.44 feet) to accommodate a landing and steps from a proposed new entry addition.
