LOCATION OF PROPERTY: 29 John Street, Part Lot 28, Registered Plan 195

PURPOSE OF APPLICATION: The applicant is requesting minor variances for the following:
Severed lot:
 Reduce the permitted lot area from 464 sq. m (4994.6 sq ft) to 325.15 sq. m (3500 sq. ft)
Retained lot:
 Reduce the permitted lot area from 464 sq. m (4994.6 sq ft) to 353 sq. m (3799.8 sq. ft)
 Reduce the front yard set-back from 6 metres (19.7 ft) to 5.4 metres (17.7 ft)
 Reduce the rear yard set-back from 7 metres (23 ft) to 3.8 metres (12.5 ft)
 Increase the permitted lot coverage from 35% to 39%
