Re Application for Minor Variance

Planning Act, R.S.O. 1990, c. P.13, ss. 45(8)

**Approval Authority:** The Corporation of the Town of Orangeville

**Re an Application By:** 2044413 Ontario Limited

**Location of Property:** Part of Lot 1, Concession C, described as Parts 7 and 8, together with and subject to a right of way, Reference Plan 7R-4794

**Purpose of Application:** The applicant is requesting a minor variance to reduce the minimum required front yard setback from 6.0 metres which shall be landscaped with the exception of driveway areas to 4.0 metres which shall be landscaped with the exception of driveway areas. The variance is required to permit the construction of a proposed addition to the existing industrial building.

We, the undersigned, in making the decision upon this application have considered whether or not the variances requested were minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,




