Purpose of Application: The applicant is requesting minor variances to reduce the minimum permitted rear yard set-back requirement from 7 metres to 3.65 metres and to increase the maximum encroachment into the minimum required front yard set-back from 0.6 metres to 2.0 metres to accommodate a porch.
