RE AN APPLICATION BY: Sunvale Homes

LOCATION OF PROPERTY: Lot 21, Registered Plan 7M-33
22 Murray Court

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to increase the maximum permitted garage door opening from 4.3 metres (14.1 feet) to 5.3 metres (17.4 feet) and the maximum permitted driveway width from 4.3 metres (14.1 feet) to 5.79 metres (19 feet) to permit the construction of a two car garage attached to the proposed dwelling.

CONDITIONS:

1. That the driveway width be limited to 4.3 metres on the municipal boulevard and to 5.79 metres on the property.
2. That the driveway be wholly contained on the municipal boulevard in front of the subject property within the extension of the side yard property lines.

REASONS FOR DECISION: The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
