APPROVAL AUTHORITY: THE CORPORATION OF THE TOWN OF ORANGEVILLE

RE AN APPLICATION BY: Howard Floyd Arnold

LOCATION OF PROPERTY: Part of Lot 8, Plan 170
5 Hillside Drive

PURPOSE OF APPLICATION: The applicant is requesting minor variances to reduce the minimum lot frontage requirement from 12 metres (39.37 feet) to 9.69 metres (31.8 feet), to reduce the minimum side yard set back requirement from 1.5 metres (4.92 feet) to 1.22 metres (4.0 feet), and to reduce the minimum lot area requirement from 350 square metres (3,767.49 square feet) to 325.15 square metres (3,500 square feet), in order to accommodate a proposed dwelling on a lot which is proposed to be severed by consent application B-4/01.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,






