LOCATION OF PROPERTY: Lot 97, Registrar's Compiled Plan 335, Part 1,
Reference Plan 7R-1565,
316 Broadway

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum rear yard set back from 7.5 metres (24.6 feet) to approximately 7 metres (22.9 feet) in order to bring the existing structure into compliance with Zoning By-law 22-90.
