DECISION OF COMMITTEE WITH REASONS  
RE APPLICATION FOR MINOR VARIANCE

Planning Act, R.S.O. 1990, c. P.13, ss. 45(8)

APPROVAL AUTHORITY: THE CORPORATION OF THE TOWN OF ORANGEVILLE

RE AN APPLICATION BY: Jody and Allison Cummings

LOCATION OF PROPERTY: Part of Lot 44, Block 7, Registered Plan 138  
24 Sarah Street

PURPOSE OF APPLICATION: The applicants are requesting minor variances to reduce the minimum required lot area from 464 sq. metres (4,994.6 sq. feet) to 328.1 sq. metres (3,531.75 sq. feet), reduce the minimum lot frontage requirement of a corner lot from 17 metres (55.8 feet) to 16.22 metres (53.22 feet), reduce the minimum rear yard set back requirement from 7 metres (22.97 feet) to 1.4 metres (4.59 feet), reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to 3.28 metres (10.76 feet) and to reduce the minimum exterior side yard set back requirement from 3.5 metres (11.48 feet) to 3.13 metres (10.27 feet). The lot is proposed to be severed by Consent Application File B-2/04 and the variances are required to bring the existing structure into compliance with Zoning By-law 22-90, as amended.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,






