PURPOSE OF APPLICATION: The applicants are requesting a minor variance to reduce the minimum interior side yard setback requirement from 1.2 metres (3.94 feet) to approximately 0.6 metres (1.97 feet) to accommodate a carport.





CONDITION:

- 1. THAT the existing grades on the property line between 90 and 92 Town Line not be altered as a result of the construction of the proposed carport.**
- 2. THAT the roof drainage from the proposed carport be directed to either the front or the rear of the carport. Runoff from the roof is not to be directed to the side yard between the carport and 90 Town Line.**

REASONS FOR DECISION: The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
