Location of Property: Part of Block 115, Plan 334, Part 2, Reference Plan 7R-3997
62 Amelia Street

Purpose of Application: The applicants are requesting a minor variance to increase the maximum permitted width of a driveway from 5.2 metres to 5.4 metres for a lot with a frontage of between 9.0 metres to 12.0 metres to accommodate the number of legal parking spaces required for a single detached dwelling with a second dwelling unit.
