LOCATION OF PROPERTY: Lot 10, Registered Plan 43M-1120
186 Howard Crescent

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum rear yard set back requirement from 7 metres (22.97 feet) to 4.34 metres (14.24 feet) to construct a proposed above grade deck having the approximate dimensions of 3.05 metres x 7.3 metres (10 feet x 24 feet) plus stairs.
