Lots 1 and 2, Registered Plan 159

PURPOSE OF APPLICATION: The applicant is requesting minor variances to reduce the number of required parking spaces from 31 to 23 and to increase the maximum permitted lot coverage from 30% to 38% to accommodate a proposed chapel addition. The applicant owns adjacent property which is used for overflow parking.

CONCUR in the following decisions and reasons for decisions made on the 5th day of October, 2011.


