Explanatory note: The applicant wishes to obtain a Minor Variance from the Committee with regards to the interior side yard requirement. The interior side yard requirement is 1.2 meters (4 ft) whereas 1.012 meters (3.3 ft) is provided. This Minor Variance is requested in order to place the property in a legal status in accordance with the Town of Orangeville by-laws. The subject property is zoned R2 - Residential Second Density Zone under By-law No. 60-77 as amended by By-law No. 66-85 of the Town of Orangeville and designated Low Density Residential in the Official Plan for the Orangeville Planning area.
