LOCATION OF PROPERTY: 130 Burbank Crescent
Part of Lot 280, Registered Plan 110, more particularly described as Part 8 on Reference Plan 7R-557

PURPOSE OF APPLICATION: The applicants are requesting minor variances to widen the maximum permitted width of the driveway from 5.2 metres to 5.9 metres and to reduce the required number of parking spaces for the dwelling unit and the accessory apartment from 3 to 2.

CONCUR in the following decisions and reasons for decisions made on the **5th day of October, 2011.**


