PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum lot area from 630 sq. metres (6,781.49 sq. feet) to 607 sq. metres (6,533.91 sq. feet) in order to bring the lot area into compliance with Zoning By-law 22-90, as amended.
