RE APPLICATION FOR MINOR VARIANCE

APPROVAL AUTHORITY: THE CORPORATION OF THE TOWN OF ORANGEVILLE

RE AN APPLICATION BY: Sunvale Homes

LOCATION OF PROPERTY: Lot 33, Registered Plan 7M-21  
79 Oak Ridge Drive

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum exterior side yard set back requirement from 3.5 metres (11.48 feet) to 2.72 metres (8.92 feet) in order to add a covered porch to the side of a proposed dwelling unit. The variance would permit an increase in the permitted encroachment for a covered porch from 0.6 metres to 0.78 metres into the exterior side yard.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,
