RE AN APPLICATION BY: St. Mark's Anglican Church

LOCATION OF PROPERTY: Lot 8 and Part of Lot 9, Block 4, Registered Plan 159
5 First Avenue

PURPOSE OF APPLICATION: The applicant was recently granted a minor variance (File A1/08) to reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to 4.4 metres (14.4 feet) to accommodate a landing and steps from a proposed new entry addition. The applicant is requesting a further minor variance to reduce the minimum front yard setback requirement from 4.4 metres (14.4 feet) to 4 metres (13.12 feet) to accommodate a change in the construction methods for the proposed new entry addition.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,
