PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum permitted front yard setback to the front wall of the garage from 6 metres (19.69 feet) to 5.63 metres (18.47 feet) to legalize the existing garage.

CONCUR in the following decisions and reasons for decisions made on the 7th day of April, 2010.


