LOCATION OF PROPERTY: 15 Rose Street
Lot 75, Registered Plan 7M-6

PURPOSE OF APPLICATION: The applicants are requesting a minor variance to widen the maximum permitted width of the driveway from 5.2 metres (17.06 feet) to 5.4 metres (17.72 feet). The variance is required to accommodate a third parking space to legalize an existing accessory apartment.
