PURPOSE OF APPLICATION: The applicant is requesting a minor variance to increase the amount of permitted other commercial retail floor space from 4,794 square metres (51,604 square feet) to 5,723 square metres (61,604 square feet) by transferring 929 square metres (10,000 square feet) of unused available office supply establishment space to the other commercial retail category to permit a further retail development.
