LOCATION OF PROPERTY: Parts 2, 3, 5, 11, 12, 13, 14, 16 and 17, Reference Plan 7R-5082
55, 65 and 75 Fourth Avenue

PURPOSE OF APPLICATION: The applicant is requesting minor variances to increase the amount of permitted other commercial retail floor space from 3,865 square metres (41,604 square feet) to 4,794 square metres (51,604 square feet) by transferring 929 square metres of unused available commercial and office floor area to the other commercial retail category to permit a further retail development.
