PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the requirement for a front yard landscaping strip from 3 metres (9.8 feet) to 0 metres to accommodate a proposed commercial development.







CONDITIONS:

1. THAT, as part of the site plan submission for the development of the property, the applicant submits a landscape plan to be approved by the Town for the boulevard area in front of the property.
2. THAT the applicant be required to maintain the boulevard landscaping at his cost in a manner satisfactory to the Town.

REASONS FOR DECISION: The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
