LOCATION OF PROPERTY: Part of West 1/2 Lot 3, Conc. 2, WHS and Blocks 83 and 84, Plan 333, more particularly described as Parts 3, 4, 9 and 10, Reference Plan 7R-4883
162 Lisa Marie Drive

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum rear yard set back requirement from 7 metres (22.97 feet) to 4.5 metres (14.76 feet) in order to construct a proposed dwelling unit on the lot which is currently vacant.




