RE APPLICATION FOR MINOR VARIANCE

LOCATION OF PROPERTY: Part Lot 8, Plan 268,
Parts 12 and 13 on Reference Plan 7R-4229
19C Amanda Street

PURPOSE OF APPLICATION: The applicant is requesting minor variances to reduce the minimum lot frontage requirement from 12 metres (39.4 feet) to approximately 10.4 metres (34 feet), reduce the minimum interior side yard set back requirement from 1.5 metres (4.9 feet) to approximately 0.03 metres (0.098 feet), reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to approximately 2.13 metres (6.99 feet) and to reduce the minimum lot area requirement from 350 square metres (3,767.50 square feet) to approximately 255 square metres (2,745 square feet) in order to bring the existing lot and dwelling into compliance with Zoning By-law 22-90, as amended.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,
