LOCATION OF PROPERTY: Block 158, Registered Plan 313 and Part of Block 247, Registered Plan 314
Northeast corner of Blind Line and Hansen Boulevard

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to increase the maximum permitted front yard set back requirement from 22.5 metres (73.83 feet) to approximately 76 metres (249.34 feet) to accommodate the construction of a religious institution.
