**LOCATION OF PROPERTY:** Lot 3 and Part of Lot 4, Block 6, Registered Plan 138,  
Part 1 on Reference Plan 7R-2037,  
4 Wellington Street

**PURPOSE OF APPLICATION:** The applicant is requesting a minor variance to reduce the minimum interior side yard requirement from 4.5 metres (14.8 feet) to approximately 3 metres (9.8 feet) to permit the construction of an addition on the south side of the existing dwelling.




