LOCATION OF PROPERTY: 675 Riddell Road  
Part of Lot 1 Concession C,  
Parts 9, 10 and 11 on Reference Plan 7R-4794

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to increase the maximum permitted height of an accessory building from 4 metres (13.12 feet) to 7.6 metres (24.93 feet). The variance is required to accommodate a pitched roof on a proposed accessory building to maintain the architectural aesthetics of the existing building. The purpose of the accessory building is to provide additional storage for the existing business operating on the property.

WE, the undersigned, in making the decision upon this application have considered whether or not the variances requested were minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,
