Location of Property: 77 Meadow Drive
Lot 1, Registered Plan 308

Purpose of Application: The applicants are requesting minor variances reduce the minimum rear yard set-back requirement from 7 metres to 4.78 metres and to increase the maximum permitted lot coverage from 40% to 42% in order to accommodate a proposed deck at the rear of the dwelling.
