Location of Property: 82-98 Winterton Court
Block 7, Registered Plan 7M-71

Purpose of Application: The applicant is requesting a minor variance to reduce the minimum rear yard set-back requirement from 6 metres to 4.32 metres to permit the construction of unroofed, unexcavated, unenclosed decks and stairs for a proposed townhouse development.



However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

Conditions:

1. **That the applicant provide the Town with written confirmation stating that satisfactory provision of access for the rear yard and infiltration gallery protection and maintenance has been provided.**

3. The requested variances are desirable for the lot.
4. The requested variances are considered minor in nature.
