Purpose of Application: The applicants are requesting a minor variance to reduce the minimum rear yard set-back requirement from 7 metres to 3.6 metres in order to accommodate a proposed deck.

Conditions:

1. That the owners provide screening or lattice to the upper level deck to afford a level of privacy between the adjacent property to the east.

Reason for Decision:

The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
