Explanatory note: The applicant wishes to construct an addition to an existing retail store and requires a variance to the rear yard requirement. The By-law requires 25 feet, whereas the applicant proposes 7 feet. The subject property is zoned C1 - General Commercial, under By-law No. 60-77 of the Town of Orangeville, and is designated General Commercial in the Official Plan.
