Location of Property: 40 Murray Court
Lot 12, Registered Plan 7M-33

Purpose of Application: The applicant is requesting minor variances reduce the minimum set-back requirement from Highway 9 from 13.7 metres to 10 metres and to permit a deck greater than 1.2 metres in height to be located within the established side yard with a side yard set-back of 8.33 metres.
