Location of Property: 155 Burbank Crescent
Part of Lot 263, Plan 110, designated as Part 10, Reference Plan 7R-516

Purpose of Application: The applicant is requesting a minor variance to reduce the minimum required width of two parking spaces from 2.7 metres x 5.5 metres to 2.4 metres x 5.5 metres to permit an accessory apartment.

Conditions:

1. **That the width of the existing driveway be widened to a minimum of 5.1 metres up to the permitted maximum width of 5.2 metres in order to accommodate one standard parking space measuring 2.7 metres x 5.5 metres in front of the deck.**

Reason for Decision:

The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
