Location of Property: Part of Lot 18, Registered Plan 7M-43,
Part 1, Reference Plan 7R-5865
11 James Arnott Crescent

Purpose of Application: The applicant is requesting a minor variance to increase the maximum permitted width of a driveway from 5.2 metres to 5.6 metres for a lot with frontage of between 9.0 metres and 12.0 metres, to accommodate the minimum required number of legal parking spaces for a semi-detached dwelling and a second dwelling unit.


