LOCATION OF PROPERTY: Lot 14 Block 10, Registered Plan 212,
30 McCarthy Street

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum front yard set back requirement from 6 metres (19.69 feet) to approximately 2.5 metres (8.2 feet) in order to accommodate an enclosed porch at the front of the dwelling.
