PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the minimum rear yard setback requirement from 7 metres (22.97 feet) to approximately 2.54 metres (8.33 feet) to permit the construction of a 4 by 9.1 metre addition at the rear of the existing dwelling.







CONDITION:

1. THAT the roof drainage from the proposed addition be directed to the side yard, and not toward the rear property line.

REASONS FOR DECISION: The variance as approved is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
