Re an Application By: Julie Elsdon-Height and Bradley Height

Location of Property: Part of Lot 290, Plan 110, designated as Parts 8 and 9 on Reference Plan 7R-517, municipally know as 66 Burbank Crescent

Purpose of Application: The applicants are requesting minor variances to reduce the minimum required width of two parking spaces from 2.7 metres x 5.5 metres to 2.4 metres x 5.5 metres to permit an accessory apartment.
