APPROVAL AUTHORITY: THE CORPORATION OF THE TOWN OF ORANGEVILLE

RE AN APPLICATION BY: Sunvale Homes

LOCATION OF PROPERTY: Lot 19, Registered Plan 7M-29
67 Buena Vista Drive

PURPOSE OF APPLICATION: The applicant is requesting a minor variance to reduce the number of required parking spaces from 6 to 5 spaces. The variance is required to accommodate a set of stairs leading from the garage into the house.

The applicant is also requesting a minor variance to reduce the minimum required exterior side yard set back from 3.5 metres (11.48 feet) to 2.9 metres (9.51 feet) to permit the construction of the "Warwick B" model dwelling.

WE, the undersigned, in making the decision upon this application have considered whether or not the variance requested was minor and desirable for the appropriate development and use of the land and that the general intent and purpose of the zoning by-law and the official plan will be maintained, or in the case of a change in a use of property which is lawfully non-conforming under the by-law as to whether or not this application has met the requirements of Section 45(1) of the Planning Act,


