PURPOSE OF APPLICATION: The applicant is requesting an increase of the ground floor area permitted as an accessory use retail store of a warehouse from 20% to 32.5%. The dwelling on the subject property is currently used as a warehouse with a retail outlet.







**CONDITIONS:** That the accessory retail store not occupy more than 28% of the ground floor area.

**REASONS FOR DECISION:** The variance is considered minor in nature. It is the opinion of the Committee of Adjustment that the general intent and purpose of the Official Plan and Zoning By-law are maintained and the proposal is desirable for the appropriate development or use of the land, building or structure.
