**Location of Property:** 97 Jeffers Court  
Part of Lot 70, Plan 330, Part 2 on Reference Plan 7R-6089,  
Block 38 on Registered Plan 7M-46

**Purpose of Application:** The applicant is requesting a minor variance to reduce the minimum lot frontage requirement from 17 metres (55.8 feet) to 14.6 metres (47.9 feet) to accommodate a proposed single detached dwelling.


