





PART A - THE PREAMBLE does not constitute part of this Amendment.

PART B - THE AMENDMENT, consisting of text constitutes Amendment No. 31 to the Official Plan for the Town of Orangeville.

PART A - THE PREAMBLE

1. Purpose of the Amendment

The purpose of the amendment is to:

- i) Reduce the public notification procedures for Official Plans, Community Improvement Plans and amendments thereto, from thirty (30) days to twenty (20) days.

2. Basis of the Amendment

The Public Meeting for this amendment to the Official Plan for the Town of Orangeville was held on October 15, 1991, at which time the Planning and Development Committee recommended that,

" That Staff be authorized to prepare an Official Plan amendment, to reduce the public notification procedures for Official Plans, Community Improvement Plans and amendments thereto, from thirty (30) days to twenty (20) days"

PART B - THE AMENDMENT

The Official Plan for the Town of Orangeville is amended as follows:

1. Section H, "Implementation", is amended by adding "Section H11 - Public Notification":
 - (a) A public meeting shall be held in accordance with the requirements of Section 17(2) and (3) and Section 34(12) and (13) of the Planning Act S.O. 1983 and notice of the meetings shall be given in accordance with the relevant regulations passed pursuant to the above noted sections of the Planning Act except where the Official Plan contains alternative notice procedures in accordance with Sections 17(4) and 34(14) of the Planning Act S.O. 1983.
 - (b) A public meeting shall be held in regard to an amendment to the Official Plan and/or an amendment to the Zoning By-law. The public meeting shall be held not sooner than twenty (20) days after the requirements for the giving of notice, as specified in the Planning Act, have been complied with. The public meeting shall be open to the public and any person who attends the meeting shall be afforded an opportunity to make representation in respect of the proposed amendment.
